Each artist may enter up to 3 .jpg submissions of artwork they completed in the past 3 years.

### Artwork Delivery Dates: **January 6 or 8, 2022 – 10 am – 4 pm**

**Entry Fee:** \$30 Entry fee for non-members; No entry fee for current FY 2022 RCAC members

### Exhibit Dates: **January 13 – March 10, 2022**

**Pick up Artwork:** March 12, 2022 – 10 am – 4 pm

**No Theme:** Artists Choice

**Reception and Award Ceremony:** **Saturday, January 22, 2021– 4-6 pm** Public invited to attend.

### Entry Rules and Policies:

1. Adults, 18 years and older, may submit up to 3 pieces of artwork in various mediums in this Juried Competition.
2. A \$30 entry fee per artist is due for this Juried Competition. Checks should be made payable to RCAC (Rockmart Cultural Arts Center). No entry fee is due if artist is a current FY2022 RCAC member.
3. Artwork must be original artwork, unpublished works to which the artist possesses common-law copyright. Artwork must be created with in the last 3 years and not have been in any of RCAC's previous shows.
4. Artworks must remain in the gallery until the end of the exhibit or date agreed with RCAC.
5. If artwork is listed for sale, and the work sells, the gallery retains **20%** commission. The gallery will handle all sales. Buyers will be able to take possession of the work at the end of the exhibit. The artist will receive a check once the show ends and all artwork have been removed from the gallery.
6. The RCAC Visual Arts Committee reserves the right to refuse works that are deemed unsafe or inappropriate. Artwork must be family friendly.
7. The art entries, form, labels and entry fee must be delivered on the delivery dates and filled out correctly. Accepted works will be listed on the RCAC form and any attached sheet as necessary. Each entry must have the information form attached to the back of *each* artwork.
8. Unless the artist requests otherwise (in writing), images may be used for the purpose of publicity in print or on the Internet by RCAC.
9. Work not picked up within 90 days of the close of the show may be sold with all proceeds going to RCAC. Special arrangements may be made with RCAC to schedule a pick up after the 90 day period.
10. Artwork must be framed and wired; ready for hanging and width not larger than 40" (including frame). Do not use saw tooth hangers. A gallery wrapped canvas does not need to be framed, but we prefer sides to be painted.
11. You should provide a base or stand for very large 3-D artwork. We have pedestals, etc. for small work.
12. Quilts and other fabric wall hangings must have a sleeve or other place for curtain rods or similar hardware, or otherwise be ready to hang.
13. Security will be provided, however RCAC, The City of Rockmart, nor Polk County will not be held responsible for lost, stolen or damaged items.

Seth Fitts' work may conjure thoughts of storybooks, memories of childhood, or lingering images from a dream, but there's more than the eye can see. Known to use materials such as old disintegrating books, paper, or ancillary furniture parts, in addition to wet and dry media, Seth creates mixed media work involving countless layers. 2. Each artwork must have: title, date created, medium, price or NFS, and dimensions (including frame).
3. Entries must include: artist's name, mailing address, email address, and phone number (s).
